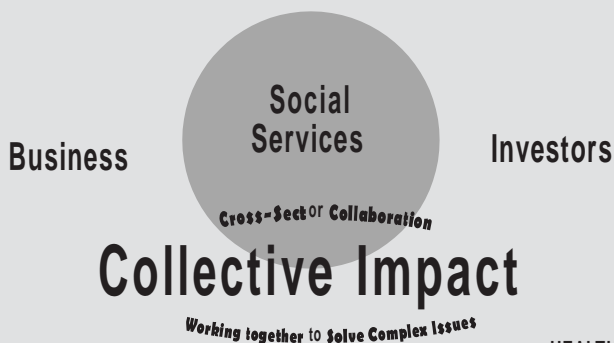
This year an anonymous donor has pledged \$25,000 to match dollar-for-dollar, gifts through UA Cares to the Arizona Assurance Endowment.
